

## Message in a (Covid-19 vaccine) bottle.

*This three-part story is being related by a special  $E=MC^2$ -Conversant, mythical dove-bird, one of only two in the Latin-American-Caribbean hemisphere of planet earth.*

Welcome aboard, my homo sapiens friends. Now, just hold on and stay within my wingspan as we soar up into my 3D, 360-degree unencumbered transit medium. Oh, just a word of advice about being on board – it's like riding a motorcycle, you have to lean with me. That's it – you've got it. Amazing how much you can assimilate so quickly.

Excellent indication of your ability to understand and appreciate the Big Picture story that I'm about to relate to you. A story that's based on verifiable facts and data but I don't claim to be neutral. Indeed, I intend to put forward the other – seldom heard point of view – with a good dose of artistic license. Preliminaries over, let's go. There's no time to waste.

In fact, the time for action was yesterday, my terra firma friends. Each passing day makes it more difficult for younger people. Born and schooled into compliance they'll be too busy ensuring their social scores don't hit rock bottom and colour-coded health status remains Green.

Never knowing which of their neighbours or work colleagues, friends or relatives, lovers or strangers will snitch on their medical martial-law transgressions to the state-Stasi online public health services or directly to the police-state and total surveillance GCHQ networks.

It probably escaped your attention – my featherless friends – as it was meant to, that the British government behind the cover of Covid-19 hysteria, subordinated Public Health England within a new *Joint Biosecurity Centre* (JBC), that's headed by a former director of GCHQ.

Your personal health, is now a national bio-security issue.

The JBC's definition of Covid-19 cases range from *confirmed*, which includes asymptomatic cases. *Linked cases*, are people who may not have Covid-19 but may have met someone who tested positive. *Probable*, is someone in a lockdown area, and a *possible*, is someone who may have symptoms. In other words, the JBC can declare almost anyone – anywhere – anytime: a 'case.'<sup>[1]</sup>

Who's social-outcast – *Star of David* status, will be stamped digitally on their DNA-Sat-Nav-linked mobile phones arriving at every entrance and exit point before them. All accessible to international and regional state security, health services and civil defence data terminals, 24/7.

The *New Normal* of ensuring continuing social-life and controlled travel movements, access to municipal and commercial services while avoiding unemployment and universal basic subsistence credits tied to automated withdrawals of anti-social fines from their cash-less digital wallets.

What? You don't believe me?

Well, when it really comes down to it, my free-thinking friends, there's only two ways of looking at the truth here. On the one hand, one of the super-elites' front-men Klaus Schwab (CEO of World Economic Forum) is telling you: in the post-Covid-19 *Great Reset* – they're going to eradicate war and famine – inequality and disease – and all environmental pollution too.

The same people who've been screwing you senseless, stealing wealth and power from the 99% and giving to the top 1% for centuries are now telling you, they're going to do the exact opposite.

Why would they do that? Especially, when they stand at the pinnacle of change from the new world order to the *One World Order*. An AI-driven, technocrats managed 24/7 Total Control Grid ensuring they'll know any spark of dissent – let alone resistance, before anyone's thought of it.

Why give that up, when they've spent decades planning for this exact moment in human history and the last ten years specifically – since 9/11, putting those blueprints into action?

On the other hand, just like the 9/11 war on terror to the Covid-19 war on the virus, it's all Big Lies and propaganda perpetrated by the super-elites to frighten you into relinquishing your rights and freedoms. As fear – is the ultimate currency of control – that all governments know.

If you don't comply, there's laws like UK's Coronavirus Act 2020 to make you comply; doubling fines sixteen times to £3,200 for not wearing face masks or socially-isolating. £10,000 for organising peaceful protests against lockdowns, and 'illegal' young people's parties and raves.

To whom the risk of Covid-19 mortality is *statistically zero*,<sup>[2]</sup> while their real issues of minimum wages, vanishing secure jobs, sky-high rents and un-repayable student loans are totally ignored by the politicians; systematically shitting on young people, from a great height.

They know – as you all do, life itself is a risky business. You can lock yourselves up at home or you can live life in spite of the risks, just as before Covid-19. Like they still do in Sweden. But your government tells you, they will *not allow you* to make the 'wrong' choices.

Which the British government tells you, is freedom and democracy, by doubling £3,200 maximum fines to £6,400 within six months.<sup>[3]</sup>

As the renowned veteran journalist John Pilger says, "Propaganda is far more effective in societies that regard themselves as free, than in dictatorships and autocracies." With UK's propaganda industries – amongst the world's most powerful and refined – Big Lies are constantly told in comforting Queen's English, credible sounding authoritative BBC voices.<sup>[4]</sup>

The essential difference between the actual lived experiences of the Chinese people (like former Soviet States) and Western people today, is that the former know they don't have freedom, while the latter continue to delude themselves into thinking that they do.

While the Chinese one-party-state-capitalist authorities fine and arrest un-Good citizens and deduct social credit points for non-compliance, Western police-state democracies extract dollars, pounds and Euros, inflict gratuitous violence and imprison peaceful lockdown dissidents.

As the UK Policing Minister – Kit Malthouse eagerly urges people to report their non-compliant neighbours and the bully-girl, British Bull-dog Home Secretary – Priti Patel, warns any would-be free-thinkers that they face lengthy criminal records and thousands of pounds in fines.<sup>[5]</sup>

One such dissenter, 73-year-old Piers Corbyn (former Labour Party leader's brother) has been fined £10,000 amongst some two hundred others. And 54,000 *fixed penalty* fines of hundreds of pounds have been imposed on people, for failing to comply with the lockdown regime.<sup>[6]</sup>

Fixed penalty means, there's no court or trial – only an automated appeal process designed to increase fines and criminalise the offence, if anyone dares to challenge the rigged system.

Whereas social services – true to their Nazi-SS image – have threatened to remove non-compliant parents' children. For these hapless clients, it's always the stick first and only the carrot if they comply fully and surrender any pretence of individuality.

All aided and abetted by the bought-and-paid-for mainstream media (MSM) – *armed with a lucrative advertising partnership with the British government*, using "MindSpace" behaviourists' instructions to increase everyone's sense of personal threat with hard hitting social disapproval.<sup>[7]</sup>

"You don't care about people dying," insults-to-intelligence hurled at anyone from eminent doctors and credentialed scientists to Joe Public. Anyone, who dares to question the Covid-19 narrative and lockdown regime is vilified and deemed to be a conspiracy theorist.

Or there's the German version revealed by the leaked "Panic Paper" from the Department of the Interior which said, children should be made to feel responsible: "for the painful tortured death of their parents and grandparents if they do not follow the corona rules."<sup>[8]</sup>

It tells you something, my joining-up-the-dots friends, that MindSpace was the creation of Imperial College, London, and the Rand Corporation. The former has longstanding direct financial

ties to the Bill and Melinda Gates Foundation (BMGF) – receiving \$86 million in 2020 alone, and the latter is a military-industrial complex public relations think tank.<sup>[9]</sup>

This is social engineering 2020; making ‘Good-citizens’ conform to whatever the government tells them – right or wrong, and acting as their state-Stasi snitches reporting their non-compliant neighbours and work colleagues to NHS 111, local councils and the 24/7 surveillance police.

As the Italian philosopher Giorgio Agamben says, this is the *induced* inability to assess the Covid-19 regime beyond the immediate context, in which it’s presented: That you’re a Good-citizen if you follow government policies. That you hold the high moral ground if you view these imposed policies as *obligations* to public health, as opposed to pre-Covid notions of *rights* to health.<sup>[10]</sup>

In other words – your government, stopping you thinking straight.

Like the Mindspace – B.F. Skinner’s rat studies’ guided behaviourist lackeys say: changing a person from an autonomous individual making rational decisions to a “situated decision maker,” whose behaviour is controlled by the constrained “choice environment.”<sup>[11]</sup>

Which translated into everyday English means, do as the government tells you, or else. Or as Amazon bosses gleefully say, when there’s no choice, people shop online. Ka-ching.

And the spineless Sir Kier Starmer – the leader of UK’s loyal opposition and former star of the state prosecution service, continues to bleat the lockdowns aren’t harsh enough or fast enough.

While UKs’ devolved governments’ First Ministers add their different seasonings to the same menu, ensuring the Covid-19 crisis doesn’t go to waste in furthering their own ambitions to expand their powers over their locked down citizens.

Tellingly, it’s never a free and honest debate, my captivated friends, where you’re allowed to hear, read or see other explanations by equally eminent experts that see something quite different in the same data. No, the dominant prevailing narrative is presented as the one and only truth, and alternative voices are deemed to be conspiracy theories.

Labelling critics of the official narrative ‘conspiracy theorists,’ was started by the CIA in 1967 to silence critics of the Warren Commission, which concluded – one man – Lee Harvey Oswald, had assassinated John Fitzgerald Kennedy, US’ 35<sup>th</sup> President, in Dallas in 1963.

Something that very few of the American people believed then and virtually none do today, especially following Oliver Stone’s powerful 1999 JFK film. The conspiracy theory idea, was designed to smear and ridicule anyone who raised criticisms of the Warren Commission, which today translates into any criticisms of the official Covid-19 narrative.

The Israeli government’s policy of accusing it’s critics of being anti-Semitic is a good example of CIA’s conspiracy theory in action, designed to smear and ridicule any and all critics.

Problem is, as David Icke says: “if you only see and believe the official versions of the truth, the only possible solutions are the official ones.”<sup>[12]</sup>

Make no mistake, my terra firma friends, this is *World War Three*; waged by each and every country’s government, super-elites and their corporations – against all humanity. And as in all wars – my conscientious friends – the truth, is the first casualty.

As demonstrated by lies, damned lies and Covid-19 statistics of PCR tests conjuring up anything up to 90% false positives, using amplification cycles of 37 to 40-plus, even 45.<sup>[13]</sup>

It says something when even Anthony Fauci, the US Covid-19 Czar stated in July 2020: “if you get a cycle threshold of 35 or more ... it’s just dead nucleotides, period.” Whereas Kary Mullis, the test inventor said: “... with PCR, if you do it well, you can find almost anything in anybody.”<sup>[14]</sup>

He was right; they’re finding fragments of Covid-19 in nine out of ten perfectly healthy people around the world and labelling them “asymptomatic cases.”

A concept that was “invented” about a year ago, according to Dr. Michael Yeadon, the former vice president of Pfizer. He explains: “It’s not possible to have your body full of respiratory virus to the point of being infectious, for you to not have symptoms, that others can see.”<sup>[15]</sup>

As Stacey Lennox (journalist and author) points out, the very idea of “asymptomatic cases” vanish in a puff of smoke, once you realise this fundamental truth. Like the Chinese study of 10 million people with 300 asymptomatic cases of Covid-19, none of whom infected anyone.<sup>[16]</sup>

This explains why the vast majority of ‘cases’ don’t feel sick but are forced to quarantine anyway, as are their families and contacts. First time in history, healthy people quarantined.

Pietro Vernazza, a Swiss infectious disease specialist stated back in March 2020: mass testing was nonsensical because 90% of the population show no symptoms.<sup>[17]</sup> Even those that are sick, the medical journalist and TV film producer Del Bigtree explains, largely only experience flu-like symptoms and recover perfectly within two to three weeks.<sup>[18]</sup>

Hundreds and thousand of such deemed Covid-19 infections are labelled ‘cases,’ despite having no symptoms, contradicting all medical training and textbooks, and then *mendaciously* conflated with all cause death numbers; rendering the Hippocratic Oath the hypocrites’ charter.<sup>[19]</sup>

The MSM in turn, deploys these thousands of context-less, daily ‘cases’ and death tolls like Richter 8 scale earthquake casualties, and politicians and their chosen science and health experts use Titanic-disaster-like sound-bites to entrench the official scare-mongering narrative.

That there’s a worldwide raging 1918 Spanish flu-like pandemic that can only be checked with more and more lockdowns, regardless of clear evidence showing such policies lead to higher rates of infections and deaths, than those nations and states that did not lockdown.<sup>[20]</sup>

Like the Swiss Policy Research evidence – based on published and peer reviewed data puts it: *lockdowns have had no significant effect on the pandemic*, and even the World Health Organisation (WHO) says they’ve caused a “terrible global catastrophe.”

While the UN warns, lockdowns may put: *the livelihood of 1.6 billion people at acute risk and may push an additional 150 million children into poverty.*

Whereas in Sweden, the report says: “covid mortality without a lockdown is comparable to a strong influenza season and close to the EU average.”<sup>[21]</sup> As of late August 2020, Sweden had an infection rate of 37 cases per 100,000 people – far lower than France’s 60 and Spain’s 153.<sup>[22]</sup>

As for the UK, Richard Tice – the former MEP informed the Cambridge Union students debate, Britain’s death rate per capita is the “worst in the world, and about 25% worse than Sweden.”

In this online debate of late January 2021, Cambridge students voted 362 votes to 309 to approve the motion: “This house believes lockdown was a mistake.”<sup>[23]</sup> A “mistake” verdict, from the UK’s establishment elites is a damning indictment of the Covid-19 lockdown regime.

In terms of mask wearing, the Swiss Policy Research charts clearly show infections increasing massively following mask mandates in Austria, Belgium, France, Germany, Ireland, Italy, the UK, and within US states of California, Hawaii and Texas.<sup>[24]</sup> (See graphs in References).

Clearly, masks are about demonstrating compliance and have nothing to do with public health. While social-distancing was an idea of an American 15-year old school girl in 2006, who’s father just happened to be a senior researcher at Sandia National Laboratories, that was working on pandemic emergency response plans for the US Department of Homeland Security.<sup>[25]</sup>

Even the WHO initially said face masks couldn’t prevent viral infections, but then Dr. Andreas Voss revealed on 24<sup>th</sup> July, 2020, they were made mandatory “not because of scientific evidence, but because of political pressure and public opinion.”<sup>[26]</sup> Public opinion, in this case means the hysteria created by the MSM.

Whereas the actual cold reality in mid-December of 2020 was that: *just 377 healthy people under 60* had died *with* Covid-19 in England and Wales, from the start of the ‘pandemic.’<sup>[27]</sup>

To put that 377 number into its true context and correct perspective, my enlightened friends, the England and Wales’ 2019 all causes daily death rate was 1,454 people – while the annual total was 530,841.<sup>[28]</sup> So what we’re talking about is 0.07% of annual deaths, over nine months.

As Giorgio Agamben says, the *induced* inability to see the Covid-19 narrative other than how it’s presented.

Of course it strikes the immune compromised, the chronically sick and the elderly relatively hard compared to the under 60s population. Though fortunately even in the hardest-hit 80-plus group, the average age of Covid-19 fatalities is slightly above the average for all cause deaths.<sup>[29]</sup>

To whom the seasonal flu – let’s not forget my terrestrial friends – is not much kinder. It killed at least 20,000 British people in January 2018 alone, from a seasonal death toll of over 64,000.<sup>[30]</sup> (Using today’s data manipulations – almost all 64,000 would be deemed Covid victims).

As they say in the MSM industry, never let the facts stand in the way of good-for-ratings story. They keep screaming from the rooftops, there’s a raging and murderous Covid-19 pandemic – the symptoms of which: “strangely resemble a cold and bad flu season, with lots of malpractice thrown in.” As John C.A. Manley (author and ghost-writer for doctors) aptly puts it.<sup>[31]</sup>

Unsurprisingly, the USA’s Centres for Disease Control and Prevention (CDC) conceded in June 2020: a Covid-19 infection mortality rate of 0.26%. That’s, one in 400 – similar to a bad flu season. Furthermore, Genevieve Briand from Johns Hopkins university stated: *Of the 1.7 million deaths from mid-March to mid-September 2020, only 200,000 – 12%, are actually Covid-related.*<sup>[32]</sup>

Seasonal flu mortality rate is usually around 0.1%, but once you strip away the inflated numbers created by dying *with Covid-19*, as opposed to *of Covid-19*, the difference evaporates.

Which also explains why the annual flu season miraculously vanished across the entire planet in 2020-21. All it’s casualties, young and old, frail and healthy, gobbled up by the voracious Covid-19 cosmic black-hole; gravitational pull so strong no light or truth escapes its narrative.

Quite miraculously, flu cases (illnesses) in the US dropped to almost zero during the 2020/21 flu season, down from CDC estimates of 39 to 56 million during 2019/20 season.<sup>[33]</sup>

As the Mailonline reported in late October 2020: “Globally it is estimated that rates of flu may have plunged by 98%, compared with the same period last year.” Of course, it rejected the ‘conspiracy theory’ idea that flu cases were being diagnosed as Covid-19.<sup>[34]</sup>

Whereas the CDC has no such qualms, its website counts all *Deaths involving Pneumonia, Influenza or Covid-19 in one column*, following the 2014 onwards openly admitted practice of conflating flu cases with other respiratory diseases *to force up flu vaccine uptakes.*<sup>[35]</sup>

Lying is perfectly acceptable within this narrative, as it’s claimed to be for a good cause. The issue here, my rational-minded friends, is one of narrative. Even where the data has clearly shown lockdown areas led to increased infections and deaths, as in the Swiss Policy Research papers, the same data is interpreted to support the opposite point of view.

Those following the official narrative argue, the lockdown areas had a more virulent form of the virus and would have had even more infections and deaths, if they had not locked down severely. Thus, contradictory data is consigned to the dustbin of history; the world before Covid-19.

Findings of expertly produced and peer reviewed scientific studies are rendered irrelevant and the official narrative of a raging pandemic is imposed on you, or you’re coerced into accepting it. Dissent is not on the agenda.

You can comply willingly or they’ll keep doubling the fines and shoving-in-you-face £6,400 penalty notices (the new ten times larger No Smoking signs), alongside face-nappies and social-

isolation signs at every thoroughfare and transit point.<sup>[36]</sup> Your democratic government muzzling you to prevent any normal human interactions; lest you discuss something unapproved of.

Using motorway and other road signs as *government propaganda billboards* (and town hall and city Tannoy PA systems), all transmitting 24/7 ideological bludgeoning; Face Masks! Social-Isolation! £6,400 fine! The connection to road safety? Pretext for ‘smart’ signs.

Then they have the bare faced cheek to claim popular support for their policies, knowing most ordinary people can’t afford to lose £200, let alone thirty-two times that.

The only real debate that takes place is at the top of the Bilderberg, Davos and secret societies’ pyramids; super-elites and corporate interests discussing how best to achieve their objectives. They set the over-arching agenda that the technocrats and government functionaries carry out, while 99.999% of you human beings have absolutely no say in it.

Whichever political party or candidate you vote for.

Yes, you can elect this or that party or this or that leader, but only those committed to the over-arching agenda are allowed to stand, much less win. It’s *all stitched-up – start to finish*, as the zany comedian-actor Russell Brand has succinctly put it.

So, what does that tell you – about your freedom and democracy, my Covid-19 ensnared friends? The plain truth of the matter is that the super-elites are the *super-parasites*, determined to get their way by *any means necessary*, because they know history is written by the winners.

How is that different from ISIS’ Islamic fundamentalism; you convert to the Wahhabi version of Islam or we chop your head off. Or as US military soldiers are fond of telling occupied native people around the world: *You will work with us; you sure as hell don’t want to be against us.*

The only difference is severity of punishment, the principle is exactly the same. We claim the right to deprive you of your autonomy – what are you going to do about it?

You break the law!

They’ve left you no other option, my locked-down, scared-shitless, human friends. I’m not saying you rob and steal. I’m saying you defy unjust laws – as has happened throughout human history. Never forget – for a single minute, the human spirit is irrepressible.

You’d be in good company too, alongside the former British Supreme Court Judge Lord Jonathon Sumption: “I’m not a scientist, but it is the right and duty of every citizen to look and see what the scientists have said and analyse it for themselves, and draw common-sense conclusions.”

In regard to the Derbyshire police pouring toxic chemicals onto beauty spots to stop people travelling there to exercise, he said: “This is what a police state looks like.”<sup>[37]</sup> Government ministers expressing preferences with no legal authority, and the police enforcing them.

Six months later he told a Big Brother Corporation’s self-censored reporter, people should be allowed to make their own decisions in light of their own health and circumstances, and that “the law should be a secondary consideration.”<sup>[38]</sup>

That, from a senior establishment judge is good enough for me. How about you, my hitherto law-abiding friends?

No, you don’t have to decide right now. I wouldn’t do that to you. I want you to make up your own mind – after hearing the Big Picture story. You’ve heard their narrative, 24/7, form every controlled MSM newsprint, TV, Radio and Big Tech’s social media platforms throughout 2020 and beyond. Now, it’s time for you to learn what they’ve censored, marginalised and kept from you.

Would you concede the following hypothetically, my free-thinking friends? Let’s suppose that there is a cult of super-parasites that seek to take control over all humanity. Do you think they would

Just as Oliver Stone demonstrated in his JFK film: The plot must succeed – Kennedy must die. The perpetrators must be on the winning side and never held accountable for anything by anybody. Above all else, the plot has no compromising connections, except at the most secret point.

So the question is not who killed Kennedy, but why? Who benefitted? Who has the power to cover it up?

If you've conceded the possibility – my featherless friends, you've accepted it's plausible. To support my case, I would cite the above examples from 9/11 to Covid-19 as ticking all the super-parasites' wish-list. Enabling them to establish the entire 5G Total Control Grid infrastructure, while the masses of people are under lockdowns.

Conveniently, demonstrations and rallies, mobilisations and protests, face to face community gatherings and discussions are effectively banned. That's how they've got round democracy.

While 9/11 achieved a lot, from the Patriot Act enabling the US military to kidnap and torture anyone worldwide, maim and murder thousands of Muslim men, women and children via drone strikes, and to terrorise their communities going about their everyday business.

It also created an all pervasive Homeland Security network to Over-watch all its own population too, with a budget growing from \$17.1 billion before 9/11 to \$64 billion by 2020.<sup>[39]</sup>

Whereas Global Warming – in the end, proved to be a tired old horse unable to finish the race. Unable to deliver the deep, transformative society changes, required by the super-parasites. As Patrick Wood of *Technocracy Rising: the Trojan Horse of Global Transformation*, informs us.<sup>[40]</sup>

The Covid-19 public health paradigm however is a winning horse. Able to completely transform human society into the *New Normal* via mandatory vaccinations, accomplishing centralised test and trace, AI controlled surveillance of everyone worldwide, 24/7.<sup>[41]</sup>

All financial transactions in the cash-less *New Normal* will be centralised; every yuan and dollar, pound and Euro, spent, borrowed or saved, date, time, location, from who to whom, permanently recorded. Every byte of data mined for ads revenues, spending behaviours, financial contacts, and used by governments and security services to ensure compliance, or blackmail.

The latter, the universal security services' compliance and recruitment tool, as demonstrated by Jeffrey Epstein's "Lolita Express" CIA/MOSSAD operations, before he met his untimely suicide. (If he committed suicide, so did Martin Luther King, Robert F Kennedy and Malcom X).

A centralised cash-less society, alongside the 24/7 universal surveillance network will enable the super-parasites to take decisive control over all information and data worldwide. The power to define the current narrative, re-write histories and control the future.

As George Orwell said in his prophetic 1949 book called *1984*: "those who control the present, control the past and those who control the past control the future."<sup>[42]</sup>

From which it's but a short step, to taking possession of All planet earth's natural resources. Or to call it by its other name, UN Agenda 2030. (Formerly Agenda 21).

The control over everything; the entire world population, all land and property worldwide, all animals, all forms of energy, every kind of industry and technology, and arts and leisure too. All in the name of the environment, carbon footprint, and other virtue-signalling con-tricks.<sup>[43]</sup>

Which fits in very nicely with the super-scam of Covid-19 to control everybody worldwide in the name of public health. Two sides of the same coin.

All with the potential – Nay, the intention, of central controllers to dictate the future course of humanity. With the ability to monitor, manipulate and control any possible dissent or organised resistance from any individual or organisation worldwide. That’s slam dunk! I rest my case.

Reaching its ultimate zenith under the 2020 Covid-19 lockdown regime, with Jeff Bezos’ wealth increasing from \$113 billion to \$184 billion, Elon Musk’s from \$24.6 billion to \$119 billion, and Mark Zuckerberg’s from \$54.7 billions to \$105 billion. All from March to December 2020.<sup>[44]</sup>

Whereas Bill Gates’ donation of Microsoft stock to the Bill and Melinda Gates Foundation, and his 2010-2020 *Decade of Vaccines* has doubled his net worth from \$54 billion to \$103.1 billion.<sup>[45]</sup> Clearly his philanthropic giving is a strategic form of taking, as (author) Nora Fernandez says.<sup>[46]</sup>

This is a con-trick on a scale of George Orwell’s Ministry of Truth proportions – as are all ‘philanthropic foundations’ – bar none.

While nearly 67 million Americans received reduced hours wages, 20 million lost their jobs, 98 thousand businesses closed permanently, and 12 million workers lost their employers’ health insurance.<sup>[47]</sup> To say nothing of the loss of freedoms that they thought were inalienable.

This entire iniquitous neoliberal system was, in fact, exposed quite spectacularly by the Hand of God back in October 2008. Or rather, that’s what your governments led you to believe.

The 2008, Sodom and Gomorrah act-of-God credit crunch shit-storm hit the proverbial fan, 13 months from the dam-busting blowback that foundered Northern Rock, sank Lehman Brothers and sent a tsunami tidal wave threatening to engulf every major bank on the world’s financial high seas. Exposing the entire greed-and-profits financial sector as a total fraud – when the walk-on-water banksters, faced with bankruptcy dragging them down to Davy Jones’ locker, got their bought-and-paid-for politicians to bail them out, by drowning you the taxpayers – in their sea of debt.

When the ever-expanding credit bubble inevitably exploded and the top-down hierarchical shit-storm hit the gyrating fan, governments forced the taxpayers to bailout the banksters by pouring bucketfuls of serious austerity-shit on their people’s heads, to pay for their super-parasite masters’ insatiable greed, and duly re-placed the banksters back on their fraudulent thrones.

At that precise moment of world history – the clocks stopped, and the true reality of the new world order was revealed to all – who had eyes to see.

The other point of clarification is that the new world order is a transitional phase, leading into the *One World Order*.

## Part Two:

I'm going to do a fairly sharp 90 degree turn here, my intellectually-indulgent friends. That's like – within the space of an international airline runway – at sixty miles an hour. But I assure you it's perfectly safe, entirely relevant and intimately connected.

Most establishment politicians, historians and constitutional experts insist that there is a British Constitution, though not a single document. They cite various laws from Magna Carta 1215; Bill of Rights 1689, Representation of the People Act 1918, Human Rights Act 1998 (via EU membership 1972–31<sup>st</sup> December, 2020) etc, to suggest ordinary citizens have intrinsic constitutional rights.

Different experts however cite different laws, Constitutional Conventions and Common Laws, as pertaining to a British Constitution. While Scotland and Wales have somewhat different versions and historical contentions. Even if a British Constitution was agreed by most experts, it would only be the case amongst a very small number of academics, lawyers and establishmentarians.

In almost every other nation, ordinary people and *school children* can recite central parts of their constitution. Certainly not the case in the UK, where immigrants and asylum seekers know ten times more about their unwritten constitution than born and bred Brits do. Where their Queen believes they're her subjects and don't need a constitution, and their Mother of Parliament has deemed them to be children, who can not be entrusted to make their own informed decisions.

Problem is, a lot of Brits seem to agree with this today – so the mainstream media (MSM) would have you believe. Truth of the matter is, MSM doesn't so much reflect public opinion as it informs and moulds it to the requirements of it's proprietors' and corporations' best interests.

All managed by the worldwide MSM and the likes of Big Brother Corporation's soft-cop/hard-cop routine of Auntie Beeb and Governess Beeb narratives, as befitting the occasion.

As in May 2020, when the government's slight change of Covid-19 policy from "Stay Home" to "Be Alert" was criticised for being vague by certain controlled critics, the BBC reporter went out of her way to defend the government policy on the basis: "We're not children."

Except, the British people weren't children during the previous seven weeks either, but the BBC kept parroting the government line: "Stay Home." A time, when the very concept of personal responsibility, let alone democratic rights and freedoms didn't exist on the BBC agenda.<sup>[1]</sup>

Thus the Big Brother Corporation is a flexible government propaganda agency; auntie Beeb when suggesting personal responsibility – and a no-nonsense Governess Beeb, when required.

Or as they say in free-thinking circles – my faithful friends, about The Times of London: It tells the truth 90% of the time so it can more plausibly smuggle in one in ten outright lies.

Even if the British Constitution exists as claimed by some, it's not a Constitution – requiring a two-thirds majority and *informed public debate* to change it. The above Acts can be changed or whittled away by a simple parliamentary majority, and are done so regularly.

Prime Minister Gordon Brown upon taking over from Tony Blair mooted the idea of creating a recognisable British Constitution in late 2016, but quickly dropped the idea. He realised it was fraught with difficulties in codifying it and tackling the insuperable conflicts of vested interests.

He came to realise the powers that be prefer the undefined and fluid notion of the British constitution, because they can interpret it according to the occasion.

\*\*\*\*\*

Returning to our main theme and going very much against the mainstream Covid-19 narrative, US District Court Judge William Stickman sided with the plaintiffs (small businesses) in September 2020. He said Governor Tom Wolf's decree forcing people to stay at home and ordering all "non-life-sustaining" businesses to shut down, had breached the US constitution. These measures he said were "overreaching and arbitrary" and that "they violated citizens' constitutional rights".

He stated: “The constitution cannot accept the concept of a *new normal* where the basic liberties of the people can be subordinated to open-ended emergency mitigation measures. Rather, the Constitution sets certain lines that may not be crossed, even in an emergency.”<sup>[2]</sup>

Talking of viruses, my justice-minded friends, whether *natural wild* varieties or man-made Frankenstein super-virulent Level 4 laboratory-created ones,<sup>[3]</sup> they all fall under the auspices of the United Nations’ Universal Declaration of Bioethics and Human Rights. This was agreed unanimously by all 191 UN member states in October 2005. It includes the following:

“Recognising that ethical issues raised by the rapid advances in science and their technological applications should be examined with due respect to the dignity of the human person and universal respect for, and observance, of human rights and fundamental freedoms.”

Article 3:2 “The interests and welfare of the individual should have priority over the sole interest of science or society.” (Exact opposite of what’s happening today).

Article 6 – Re Consent: “Any preventative, diagnostic and therapeutic medical intervention is only to be carried out with the prior, free and informed consent of the person concerned, based on adequate information. The consent should where appropriate, be express [sic] and may be withdrawn by the person at any time and for any reason without disadvantage or prejudice.”<sup>[4]</sup>

Whereas in the context of the Universal Declaration of Human Rights proclaimed by the UN General Assembly in 1948, the following rights and freedoms have been obliterated, de-legitimised and expunged: the right to privacy (Article 12), freedom of movement (Article 13.1) and freedom of assembly (Article 20.1).<sup>[5]</sup>

Even the Nuremberg Code of ethics and principles agreed by world leaders in 1947 following the horrendous experiments carried out by Nazi doctors on human beings has been rendered obsolete. Could that be, my observant friends, because the first sentence of Point One of the ten principles states: “The voluntary consent of the human subject is absolutely essential.”<sup>[6]</sup>

The Pfizer and Moderna Covid-19 mRNA vaccines are entirely new. They have never been used on humans before and failed miserably in animal trials, actually enhancing the disease. A phenomenon known as *antibody-dependent enhancement*.<sup>[7]</sup> So they went straight to humans!

As the cartoon in Professor Michel Chossudovsky’s book: *The 2020 worldwide Corona Crisis* aptly demonstrates with two mice talking to one another. Mouse No 1: “Are you going to get vaccinated?” Mouse No 2: “Are you crazy, they haven’t finished the tests on humans.”<sup>[8]</sup>

\*\*\*\*\*

People have been cruelly and criminally misled into believing that Covid-19 vaccines have undergone clinical trials and are proven to be safe and effective. Let me inform you, my sold-out and bamboozled friends, nothing could be further from the truth. None of these new vaccines have been tested on more than 200 people in any of the vaccine trials.<sup>[9]</sup>

All drugs manufacturers have used *interim results* from phase one of their studies to claim 90% to 95% efficacy rates. While drugs regulators and governments, MSM and social media have all colluded to hoodwink the public into believing the preliminary brief data from phase one trials is applicable to the much larger phase two and three trials, which are years from completion.

Take for instance, the Pfizer vaccine study of nearly 44,000 participants. In the phase one study group, 170 people became infected with Covid-19. As 162 were in the placebo group and 8 on the vaccine, the company claimed 95% efficacy. On a sample of *less than 0.4%* of the total study.<sup>[10]</sup>

Furthermore, this 95% efficacy rate, as Iain Davis points out in his Off-Guardian article is a relative risk reduction, not absolute risk reduction, which is 0.84%. That is, less than 1%.<sup>[11]</sup>

Let's just consider that another way, my statistical-chicanery-victim friends. Would you feel comfortable wearing a parachute that worked less than 1% of the time, but had performed 95% better than the ones that it was compared to?

The only real test is to give somebody the vaccine and then expose them to the *real, wild virus*. But of course, when they did that with ferrets it actually enhanced the disease – so they skipped the animal tests and moved on to human guinea pigs.

Under the US Federal Food, Drug and Cosmetic Act (2016), Section 564, “unapproved” drugs can be marketed in *emergencies*. Similarly, in the UK unapproved drugs can be granted emergency use under Regulation 174 of the Human Medicine Regulations 2012 Act.<sup>[12]</sup> Other nations have used similar laws, to enable these experimental vaccines to be used.

Emergency approval means that the drug or vaccine “may” be effective, whereas the non-emergency approval process means it must demonstrate “substantial” effectiveness.<sup>[13]</sup> *May be effective*, is the basis that Covid-19 vaccines are being used today – but no trials are completed.

For example, the estimated end date for AstraZeneca trials is 21<sup>st</sup> February 2023, while Pfizer/BioNTech end date is 27<sup>th</sup> January 2023. The estimated end date of phase one of the latter, is 13<sup>th</sup> June 2021. While assessment of serious adverse events is six months, after the last dose.<sup>[14]</sup>

What if completed and analysed studies in mid-to-late 2023 find serious issues, my extremely perplexed friends, how are they going to take the vaccine back out? How's that different from executing an alleged murderer, before the trial has reached a verdict?

In any case, Dr. Joseph Mercola has revealed that the vaccine trials were rigged to pass efficacy tests: “Three of the vaccine protocols – Moderna, Pfizer and AstraZeneca did not require their vaccine prevents serious disease, but prevents *moderate symptoms like cough, or headache*.”<sup>[15]</sup>

It gets even worse, I'm sorry to have to inform you – my hitherto nonchalant friends. None of the leading vaccine trials were designed to test if the vaccine can reduce severe Covid-19 symptoms, like hospital admissions, ICU or death. Or to even test if they can interrupt the transmission; prevent infection or passing it on to others.

As Professor Jonathan Van-Tam – England's deputy chief medical officer wrote in the Sunday Telegraph of late January 2021: “Even after you have had both doses of the vaccine you may still give Covid-19 to someone else and the chains of transmission will then continue.”<sup>[16]</sup>

\*\*\*\*\*

In the context of new vaccines, Alix Mayer (from Children's Health Defense) reminds us, that of the two dozen vaccines on the market in USA today, at least 66 others were tested and approved but then had to be discontinued – many due to safety issues.<sup>[17]</sup>

The USA plans to inject hundreds of millions of Americans with the Covid-19 vaccine, by hook or crook, pressure and coercion, extortion and blackmail – just like most other governments.

Even if there's only one serious injury per 1,000 vaccines given to a 100 million, means chronic harm to 100,000 – otherwise perfectly healthy people.

Not only are these vaccines hurriedly produced – by their own admission, with no statistically significant testing before use, Pfizer and Moderna are an entirely new mRNA experimental class of vaccine, that actually enhanced the disease in animal studies – as we learned earlier.

Very many eminent doctors and scientists argue they're not vaccines in the traditional manner of a weakened or dead virus, but completely new and untested gene-therapies.<sup>[18]</sup>

If that's not alarming enough, an even greater cause for concern for you hapless homo sapiens is the realisation that your governments have sold-you-out to the vaccine manufacturers. Giving them total immunity from liability, regardless of whatever injuries or deaths caused by their vaccines.

Talking of vaccine related injuries and deaths ...

The UK Medicine and Healthcare Products Regulatory Agency (MHRA) Yellow Cards adverse reactions to Covid-19 vaccines up to June 02, 2021 across all vaccines, cites 279,118 general disorders and 1,295 deaths cumulatively.<sup>[19]</sup> (It has to be said, my British friends, that the MHRA *deliberately scatters information*, to make it as difficult as possible to discern the overall data).

Whereas the European Database of adverse drug reactions for Covid-19 vaccines across all vaccines records 13,867 deaths and 1,354,336 injuries, up to June 05, 2021.<sup>[20]</sup>

As of June 11, 2021, according to the CDC's Vaccine Adverse Event Reporting System (VAERS), 358,379 adverse reactions to Covid-19 vaccines, including 5,993 deaths were recorded. These included 29,871 serious injuries.

Of the 5,993 deaths, 23% actually occurred within 48 hours of vaccination and 16% within 24 hours, while 38% occurred in people who became ill within 48 hours of being vaccinated.

They include 7 children; four 15-year-olds, two 16 years, and a 17-year-old. One 15-year-old reportedly died one day after receiving his second dose, and a 16-year-old suffered a haemorrhage and died four days later. Yet ironically, they're at *statistically zero* risk of fatality from Covid-19.<sup>[21]</sup>

But that's all coincidence, they tell you.

Before the vaccine, if people died of anything – old age, chronic illnesses, heart attacks, even auto-accidents and gunshot wounds, they were deemed to be Covid-19 deaths if they'd tested positive in previous 28 days in UK and anything from 30 to 90 days in USA.<sup>[22]</sup>

Whereas after the vaccine, any and all serious adverse effects, even deaths, are caused by coincidence, old age, chronic illnesses etc, but definitely not due to the vaccine. In fact, as Robert F. Kennedy Jr. points out, *coincidence* seems to be even more virulent than Covi19.

Let me explain how this con-trick works, my confused friends. The manufacturers claim – while keeping a straight face – if it's not headaches etc, as noted in their phase one studies, it can't be due to the vaccine. (Like the car sales-man saying it was perfectly fine, 'till you drove off the forecourt).

While the MSM forgets to remind them – or you, that the studies are years from completion, and some of the most chronic autoimmune adverse reactions only emerge years later.

If ever there was smoking-gun evidence of deliberate deceit, it's evident in the *breakthrough cases*. These are people who have been fully vaccinated for at least two weeks, but then test positive for Covid-19 anyway. As of April 30, 2021, there were 10,262 breakthrough cases according to the CDC, with 995 people needing hospitalisation, and 160 deaths.<sup>[23]</sup>

Given the contradiction of efficacy of Covid-19 vaccines, the CDC has responded by moving the goalposts! In April, 2021, it said it will no longer report breakthrough cases unless they led to hospitalisation or death, while continuing to count unvaccinated asymptomatic cases. Furthermore, it issued guidance to laboratories that it will only accept *28 or less PCR cycles for fully vaccinated people*, while it remains anything from 35 to 45 amplifications for the unvaccinated.<sup>[24]</sup>

This isn't just double standards, it's outright in-your-face, cheating and lying. There is a word for this in scientific circles: *fraud!*

The number of PCR cycles is the crux of the matter. As increasing proportions of the population are vaccinated – by any means necessary, the amplification cycles will simply be *dialled down* and the diminishing positive tests will then be claimed to be due to the success of Covid-19 vaccines.

\*\*\*\*\*

The last time vaccine companies were granted immunity from litigation was under the US National Childhood Vaccine Injury Act 1986 (NCVIA), that left the US taxpayer to pick up the \$4.4 billion bill to compensate the families of the vaccine injured and murdered children.<sup>[25]</sup>

The chronic illness rate in the USA – neurological disorders and autoimmune diseases was 12.8% in 1985/86 when children received 11 scheduled vaccines up to age 18. While mandated vaccines have risen to 54 vaccines in 72 doses, rates of autism have continued to rise dramatically from 1 in 5,000 in 1975, to 1 in 150 by 2004, and 1 in 54 in 2020.

At this rate of increase, it is estimated to effect *One in Two American children, by 2032.*<sup>[26]</sup>

The greatest number of chronic diseases today across the developed nations are autoimmune disorders, where people’s own immune system is attacking their bodies. But of course, the one product designed to alter their immune system – vaccines, is beyond question.

Anyone mentioning the idea is publicly crucified by the vaccine industry in collusion with the mainstream media; their head placed on a pike as a poignant warning to other doctors. Get out of line, and we’ll do a Dr Andrew Wakefield on you; destroy you completely.

Though he was not, and never has been anti-vaccine. He merely objected to the combined MMR vaccine as opposed to individual measles, mumps and rubella injections, given the possible link to autism and the fact that the combined vaccine had *never undergone* any studies.<sup>[27]</sup>

As Del Bigtree has revealed: *Doctors have told me, off-camera, I know vaccines cause autism – I’ve seen the research, but I will never say that on camera, because it will destroy my career.*<sup>[28]</sup>

In any case, the entire argument for giving the vaccine manufacturers complete immunity works in the belief (*the narrative*), that the Covid-19 virus is such a devastating worldwide pandemic that everybody must be vaccinated as quickly as possible. So life can return to normal.

This is simply not true, and never has been from day one.

Covid-19 is not SARS with a fatality rate of around 10%, or MERS with 34%, and certainly not Ebola fever with 50%. It’s not even close to the wildly exaggerated early WHO forecasts of 3.4%, or even Anthony Fauci and Neil Ferguson’s claimed 1% lethality rates.

The latter two, *deliberately conflated* the ten times larger Case Fatality Rate with the Infection Fatality Rate to reach their 1% conclusion,<sup>[29]</sup> in order to scare-monger and frighten the US and UK governments to introduce draconian lockdowns and everything else that followed.

Such a *basic scientific error* is either deliberate duplicity or they think the general public is stupid enough to believe their excuse of it being an accidental mistake.

The Oxford Centre for Evidence Based Medicine has estimated (amongst many other eminently qualified organisations), Covid-19 has a broad population based mortality risk of 0.012%. In other words, a 99.8% survival rate, which is not very different to a bad flu season.<sup>[30]</sup>

As Thomas E. Woods the New York Times best selling author, historian and a libertarian, pointed out back in July 2020, the fatality rate per 100,000 under 18-year old Americans was statistically zero, while for the vast majority of 15 to 64 age group (215 million people), it was 3.6 per 100,000. But the normal mortality rate for the latter group, is 335 per 100,000.<sup>[31]</sup>

This is precisely the point that the philosopher Giorgio Agamben makes; people are unable to see the Covid-19 narrative beyond the immediate context in which it’s presented. When common sense would tell them, if the normal mortality rate is 335 per 100,000 – how is 3.6 an issue?

Let’s just compare that to the normal all cause mortality rate in the USA in 2018, when there were 1 in 300 deaths by gun assault; 1 in 106 by auto-accidents; 1 in 86 by suicide; 1 in 26 via chronic lower respiratory disease, and nearly 1 in 6 by heart attacks and cancer.

Clearly the claimed Covid-19 emergency – with 1 in 400 mortality rate, is not an emergency or a pandemic. Precisely, what they don’t want you to recognise.

\*\*\*\*\*

In January 2021, there was supposedly a second deadly wave of the Covid-19 pandemic in the UK, which miraculously vanishes when it's compared to January 2015.

Taking the previous four weeks averages, the UK Office for National Statistics (ONS) data shows 11,976 deaths in 2015. Whereas in January 2021 it was 12,161. Both around 12,000. And the winter of 2014/15 wasn't a particularly severe flu season.<sup>[32]</sup> It was described as "moderate."

Never mind what the MSM keep telling you, this is the reality. There is no emergency and certainly no need for any vaccine. Let alone, extremely rushed and untested Covid-19 vaccines.

As for "variants," Dr Michael Yeadon points out, the 2019 SARS-CoV-2 virus is 20% different from the 2003 SARS-1 virus, which was easily recognised by the immune system of people who had been infected by SARS-1.

So why would any current variants – that are 99.7% identical to the SARS-2 from Wuhan in December 2019, not be recognised by our immune system today?<sup>[33]</sup>

The other issue is that in January 2015 critically ill patients were diagnosed in hospitals by *real doctors* using *observable set of facts and symptoms* and patient records, and in 2021 they were diagnosed by a PCR test that gives some 90% false positives. The problem is the PCR Test.

Talking of which, the case of Dartmouth-Hitchcock Medical Center (USA) in 2006, should be a salutary lesson for you, my heavily manipulated friends.

This is when some cases of severe coughing amongst healthcare workers were diagnosed by the PCR test and deemed to be the start of a whooping cough epidemic. Nearly 1,000 staff were furloughed and quarantined, 142 people tested positive, and thousands of people were given antibiotics. Growing the bacteria in the laboratory however, showed not a single case was real.

It was six months before Dartford Hitchcock Medical Center returned to normal.

A similar panic at a Children's hospital in Boston led Dr Trish M. Perl (epidemiologist at Johns Hopkins) to reveal: "pseudo-epidemics happen all the time." She added, "It's a problem; we know it's a problem. My guess is that what happened at Dartmouth is going to become more common."<sup>[34]</sup>

You know the rest from there ...

\*\*\*\*\*

Let's also not forget, my conscientious friends, some of the previous rushed drugs and vaccines that were foisted upon an unsuspecting public and led to devastating consequences.

In the 1950s and early 1960s hundreds of millions of people were given polio vaccines, which years later were discovered to have been contaminated with SV40, a cancer causing virus found in the kidneys of rhesus monkeys that were used to create the vaccine.

In 1976, 12 soldiers at Fort Dix (USA) were diagnosed with swine flu and the public health hysteria led to government mass vaccinations. Only one soldier actually died, but 46 million people were injected and it led to 4,000 people claiming damages of \$3.5 billion for injuries.<sup>[35]</sup>

Then there's the Thalidomide scandal of 1957 to 1961 concerning a morning sickness drug given to pregnant women that led to over 10,000 babies being born with adverse limb deformities, internal organ defects and brain damage. Eventually the UK manufacturers Distillers Biochemicals (now Diageo) paid out some £28 million compensation in the 1970s.<sup>[36]</sup>

Following this horrendous experience, serious protocols were enacted to safeguard the general public. All conveniently forgotten today.

During the 2009 H1N1 swine flu *false-pandemic* declared by the WHO, GlaxoSmithKline rushed out a vaccine that was used in several European countries. This led to 700 children falling incurably ill with narcolepsy, and becoming severely disabled.<sup>[37]</sup>

Dr Wolfgang Wodarg, as a member of the German Bundestag and Council of Europe, exposed this hoax. Yet today, he is being censored for expressing dissenting views about Covid-19.

Many years later it was officially admitted that the 2009 flu was no deadlier than any other season and the British Medical Journal (BMJ) exposed the profit-motive behind this scam. They revealed the people advising the WHO to declare a *public health emergency* and urging governments to buy billions of dollars of vaccines, had direct financial ties to vaccine companies.<sup>[38]</sup>

Let's remember this lesson of a decade ago, when European governments wasted \$3 billion on Tamiflu, marketed as a cure for the swine flu that proved to be no better than aspirin, and with very serious side effects of "renal and psychiatric events."<sup>[39]</sup>

Then there's the opioid scandal effecting some 400,000 Americans over 20 years, before three drugs companies agreed to pay \$260 million compensation in 2019.<sup>[40]</sup> Which really only occurred because they *could be sued in court*, which can't happen with Covid-19 vaccines.

So you're up the shit-creek, without a paddle.

\*\*\*\*\*

In all these cases, the public was told to "follow the science," and in each of them enormous numbers of people paid for their blind faith, with serious adverse effects to their health.

As Kamran Abbasi, executive editor of the British Medical Journal said in an editorial in mid-November 2020: "Politicians often claim to follow the science, but this is a misleading oversimplification. Science is rarely absolute."

He explained that the UK Covid-19 response has relied too heavily on government appointed scientists with conflicts of interest, "including shareholdings in companies that manufacture Covid-19 diagnostic tests, treatments and vaccines."

Which has led to suppression of science, by cherry picking favourable research and gagging dissenting scientists. As opposed to being guided by the science, he said: "The medical-political complex tends towards suppression of science to aggrandise and enrich those in power."<sup>[41]</sup>

In many ways, this BMJ editorial is sounding very similar warnings as the 2009 false-pandemic, that was motivated by WHO advisers' having financial links with vaccine manufacturers.

In any case, the Covid-19 vaccine is clearly rushed out at warp speed and is by any definition, experimental. Therefore, covered by the 1947 Nuremberg Code, adopted in the Geneva Conventions in 1949 and the International Covenant on Civil and Political Rights in 1966.<sup>[42]</sup>

In other words, my heavily fear-mongered – bamboozled and ensnared – caught in the glare of headlights – running and swerving in the middle of the road rabbit friends – either Judge Stickman is absolutely right, or National Constitutions, unanimously agreed Human Rights Declarations and Codes against human experiments, are not worth the paper they're written on?

There is no middle ground here, it's one or the other.

### Part Three:

Turning sharply again another 90 degrees and rising towards the heavens, my disorientated friends, we're going to cover another seemingly disparate issue that pertains to some two-thirds of humanity – in one way or another. Who may under the current Covid-19 worldwide lock-down regime be experiencing some profound philosophical questions.

The Covid-19 worldwide plandemic, or to call it by its proper name *World War Three*, is quite unlike any previous war, my Big Picture friends. It's a war by the world's governments, on behalf of billionaires and their corporations, against all humanity. Or is God pissed-off with government leaders circumventing His authority over his representatives. Whom today dare not open their church, mosque and synagogue doors to their own believers, for fear of government retribution. (Excommunication from the establishment).

This is heresy. And if God had a humane backbone in his entire celestial body, he would decisively smite the government leaders and their puppet masters with well-aimed fire and brimstone lightening bolts, and sack his entire sycophantic entourage of bishops, chief rabbis and ayatollahs for gross negligence of their duties to His believers.

Then start worrying about his own position, if His anointed leaders and His human creation has puts its earthly government leaders before Him; dared to change the human DNA<sup>[1]</sup> that He himself had put in place for eternity, how is he omnipotent?

While we're at it there's something else I want to get off my pigeon-dove chest, my rational-minded friends, so would you indulge me just a little longer. Yes, another 90 degrees, my spinning-top friends, though we'll be flying level and straight now.

Intelligent life – given the millions and billions of variations of species on planet Earth, has and will over the millennia and millions of years adapt to the changing environment. If certain species can not adapt, others will do so and continue the march of the myriad forms of life into the future.



Given enough time and barring some catastrophic asteroid impact or nuclear holocaust, intelligent life *and you homo sapiens* will not only thrive on planet Earth, you'll learn to harness the fundamental forces of the universe to ensure your survival. The one blot on the landscape is Biblical Armageddon, if God does exist.

Even on that point, I believe there's a test that can sway the balance of the argument. It's my contention that there will be definitive proof of intelligent life elsewhere in the universe within the next 20 years. Let the bishops, mullahs and chief rabbis consult their scriptures and pray for God's guidance – then agree with my forecast or contradict it. And we'll see by 2040 who's right.

Unless they all adopt a unified position, some are bound to be wrong. And if it's like tossing a coin as we agreed earlier, anything over 50% will fall on one side only.

Another way is for them to give us the exact date that Armageddon will take place, claiming it could happen any day for 2,000 years is as accurate as Neil Ferguson's contrived, lock-down somersaulting mathematical models that: "no serious scientist gives any validity to."<sup>[2]</sup>

That's according to Dr Mike Yeadon, with three decades long experience of working in pharmaceutical research and development, and the former Vice President of Pfizer. So I think you'll agree, my doubting-Thomas friends, he knows what he's talking about.

I readily concede, my creationist friends, some of the most impassioned opponents of the Covid-19 lockdown regime have been God-believers. Whereas the 'liberal and progressives' and especially the 'socialists' have fallen for the super-parasites' narrative, hook, line and sinker. Especially galling, as the latter know better. For whom, I have nothing but contempt.

Or perhaps, Dr Yeadon has lost his mind and is a 'contrarian scientist,' like so many other eminent and credentialed doctors and scientists who completely lost their marbles during 2020-21. So the fact-checkers would have you believe. As indicative examples, I'll only mention a few of the hundreds of world renowned health experts who have been censored during this 'pandemic.'

John Ioannidis – Professor of Medicine, Stanford University, who wrote a landmark thesis in 2005: "Why most published research findings are false." (Most downloaded paper in the Public Library of Science). Dr Scott Jensen, who is also a US senator and yet has been censored for revealing Covid-19 numbers are grossly exaggerated by 20% bonus payments to hospitals.<sup>[3]</sup>

Professor Karol Sikora, a former director of WHO and Professor of Medicine at University of Buckingham, who revealed doctors putting Covid-19 on death certificates, with "any hint" of its presence and estimated *only half* of ONS reported Covid-19 deaths were real.<sup>[4]</sup>

Professor Michael Levitt, a Nobel Prize laureate biologist who pointed out serious problems with the Imperial College model – that was never peer reviewed. Professor Carl Heneghan of Oxford University, citing flaws in Public Health England's counting: "If a person has both a negative and positive test, only their positive test will be counted."

Whereas an asymptomatic person who had tested positive could have two confirmatory negative tests, but would still be counted as a confirmed Covid-19 case.<sup>[5]</sup>

He and his colleague then pointed out, patients who had tested positive and had been discharged from hospital will still be counted as Covid-19 deaths, "even if they had a heart attack or were run over by a bus three months later."<sup>[6]</sup>

Dr Mike Yeadon, who revealed some 90% of PCR tests are false positives in an article entitled: *Lies, Damned Lies and Health Statistics*. He stated: "The likelihood of an apparently positive case being a false-positive is between 89 to 94 per cent, or near certainty."<sup>[7]</sup>

Professor Sucharit Bhakdi, a microbiologist at the Mainz university (amongst highest cited scientists) said at the outset the ‘pandemic’ was nothing more than a bad flu season. He described the lockdown measures as “grotesque,” “useless” and “self-destructive;” a “collective suicide.”<sup>[8]</sup>

Professor Karin Mölling (former chair of Medical Virology at the University of Zurich and a *published authority on viruses*), stated in an interview that Covid-19 is “no killer virus.” She said, “we need air and sun, air dilutes viruses and the sun with UV-light kills them. But not curfew!”<sup>[9]</sup>

Let’s be clear, my discerning terra firma friends, Viruses are not some alien invasion – they’re part of all earthly life, like microorganisms and bacteria. There’s some 380 trillion viruses in human bodies, 63 trillion bacteria and 6 trillion cells, but only around 250 viruses can make you ill.

The fact of the matter is, 99% of all bacteria and viruses are beneficial to human life, and necessary for evolution.<sup>[10]</sup>

Let’s also not forget, my rational-minded friends, that many eminent scientists opposed the 2009 swine flu hoax pandemic besides Dr. Wolfgang Wodarg: Professor John Ioannidis, Professor Michael Levitt, Professors Karin Mölling, Dr Sucharit Bhakti, Dr Klud Wittowski, etc.

Currently, there’s actually many hundreds of times more dissenting scientists and doctors, as well as other experts and commentators, but you’re not hearing their voices because the power of MSM and social media censorship today is almost absolute. Anyone questioning governments or the WHO’s prevailing narrative is deemed to be a conspiracy theorist.

Doesn’t matter if you’re genuinely curious, have troubling questions or just want to look at other explanations, the fact-checkers will re-direct your enquiry to the official narratives. And if you persist in looking at unapproved sources they’ll stick Fact-Check Warnings to remind you; they know *who you are, where you live, and who you work for*.

If you dare to even “like” such posts, narratives and videos, they’ll cancel your account and render you a non-person. Such is free speech, under the *New Normal* world of Google, Big Tech, and social media’s self-appointed, Ministry of Information.

They call it ‘consensus.’ That there are certain facts and data, ideas and perspectives that are agreed by the mainstream media, official experts and approved sources. Anyone questioning or contradicting this narrative is automatically a conspiracy theorist, or spreading misinformation.

Of course, they alone define the consensus; judge, jury and executioner. Deciding for you, what you should and should not know. Saving you the trouble of having to think for yourself.

Fact-checkers routinely conflate almost any critical information as being “anti-vaccine” or “misinformation,” *no matter how factual and well-grounded in science*. Anything that enables people to think for themselves is labelled anti-vaccine, anti-science, or conspiracy theory.

By this means, they ludicrously equate advocacy of the right to informed consent as promoting “misinformation” about vaccines. As Robert F. Kennedy Jr. has revealed time and time again.<sup>[11]</sup>

They even claim any discussion of corruption within the government and medical establishment is “conspiracy theory,” though the US Congress has acknowledged this within the CDC and Food and Drug Administration (FDA).

Whereas the existence of pervasive corruption and conflicts of interest within the scientific community and the medical establishment, is readily acknowledged in the literature.

A critical point to bear in mind, my free-thinking friends, is that the US government is beholden to the vaccine industry reflecting the \$295 million it spent on lobbying in 2019. This is twice as much as oil and gas and four times the lobbying power of defence and aerospace industries.<sup>[12]</sup>

This *legal bribery*, is why Adam Schiff (Congressman) pressured all social media: Youtube, Facebook, Google, Instagram, Amazon etc, to censor anyone questioning the safety of vaccines.<sup>[13]</sup>

Supposedly, my heavily manipulated and lied to friends, you live in a free and democratic society but you're not allowed to receive independent information that could help you make more informed decisions about something that you may put into your own body.

Isn't that the polar-opposite of freedom and democracy?

Worse still, the regulatory agencies supposedly protecting the general public, have conflicts of interest. The USA's FDA receives almost 50% of its budget from vaccine companies, and \$5.9 billion of CDC's \$11.5 billion budget, is related to buying, selling and distributing vaccines.

The CDC owns 57 vaccine patents and the National Institutes of Health (NIH) owns hundreds, as well as 50% of Moderna vaccine. Which means, five people at NIH stand to make \$150,000 royalties annually, from it's Covid-19 vaccine.<sup>[14]</sup>

So it's not just legislative capture via political donations but also regulatory agency capture via conflict of interest, and the corruption of the revolving door; with vaccine industry executives moving to regulatory agencies and vice versa.

Though it's more blatant in the USA, other nations' regulatory agencies also have revolving doors; foxes guarding the hen-house and taxpayers forced to pay for this systematic corruption.

\*\*\*\*\*

Returning to the fact-checkers – once again, my critical thinking friends. Their raison d'être is quite simply to serve their super-parasite paymasters. To remove and censor, unapproved narratives and silence dissenters, from Joe public to eminent world experts, and keep feeding everyone the officially approved narrative – ad nauseam.

He who pays the piper, calls the tune – I think you'll agree, my free-thinking friends.

The Poynter Institute is the centre of the International Fact-Checking Network (IFCN), that coordinates and trains worldwide fact-checkers. It's funded by so-called philanthropists like George Soros, Pierre Omidyar, Bill Gates, and the likes of US Department of State and the National Endowment for Democracy (NED).

NED's philosophy was explained by Allen Weinstein in 1991, who helped to draft the 1980s legislation: "A lot of what we do today was done covertly twenty-five years ago by the CIA."<sup>[15]</sup>

Google and Facebook are aligned with the warmongering Atlantic Council and it's "Digital Forensic Research Lab," as well as the Poynter Institute via funding partnerships. Other smaller Fact-Checker organisations are funded directly by George Soros and his Open Society Foundation, the Ford Foundation, the US embassy, and NED.

All the above have been and are today actively involved in regime change operations around the world, masquerading as 'democracy' promoting international charities.

Plus Bill Gates via BMGF, funds virtually every major world news and TV network. He gave \$383,000 to Poynter Institute in 2015, and over \$250 million to journalism to the end of 2020.

These include over \$9 million to UK's Guardian, over \$3 million to American NBC Universal, over \$4 million to French newspaper Le Monde, over \$4.5 million to the US state-funded NPR, \$1 million to Al-Jazeera, and \$49 million to the British state-funded BBC.<sup>[16]</sup>

He also funds numerous others, though the actual amounts are unclear: Pro-Publica, National Journal, Univision, Medium, Financial Times, The Atlantic, the Texas Tribune, Gannett, Washington Monthly, and the Center for Investigative Reporting.

These bought-and-paid-for journalists and fact-checkers are what Malcolm X would've termed, 'house Negroes,' who ask their slave owner – who's pain was their pain: "What's the matter boss, we sick?"<sup>[17]</sup> While the 'field Negroes' – quite rightly, wanted to burn the house down.

May these house slaves never find a moment's peace until they recognise humanity is the sum of infinitely varied, richly disparate and uniquely individual creative minds, as opposed to units and numbers to be managed and controlled for the sole benefit of the super-parasites.

Just brace yourselves once again, my indulgent friends, I'm going to do a sharp 90 degree turn to incorporate the closely aligned global warming agenda, which I assure you is intimately connected. Which is inevitable, given the global warming agenda is based on systematic data manipulations, not too dissimilar to the chicanery over died *with* Covid-19 and ridiculously high PCR test cycles.

Different temperature and data sets are calculated in different ways, my friends. Amongst which, Remote Sensing Systems (RSS) are the satellite data sets that are considered to be *quality class 1*, which have shown virtually zero rise in temperatures from 1998 to 2017. (And beyond).

However data sets are 'adjusted' every few years to allow for decaying satellite orbits and other factors and have had a strange habit of making the past cooler and the present warmer. These 'corrections' to satellite data show 140% faster warming from 1998 to 2017, compared to the previous Version of 2006. Every single data set today has had the same adjustments made.

According to meteorologist Joe D'Alwo, a co-author of a *peer reviewed study* that examined all the main data sets worldwide from NASA, to UK's Met Office: "Nearly all the warming they are now showing are in the adjustments."<sup>[19]</sup>

In other words, the only global warming that's said to have occurred is not in the original raw data, but due to "adjustments" made retrospectively. As George Orwell said: Those who control the present, control the past and those who control the past control the future.

The global warming theory is not only from the same stable as 9/11, it's the new world order's bitch, as is Covid-19. All progressing the super-parasites and their corporations' agenda, while your 'democratic' governments are the means to enforce your obedient compliance. Any questions?

China actually passed a law at the end of June 2019, rolling out a mandatory national vaccination programme that went into full effect on the 1<sup>st</sup> of December, 2019.<sup>[23]</sup>

The International Air Travel Association (IATA), encompassing some 299 world airlines expects their IATA Travel Pass to be fully operational by early summer 2021. While Singapore Airlines introduced digital health certificate testing back in December 2020.<sup>[24]</sup>

Dr Clare Wenham, assistant professor of global health policy at the London School of Economics has warned: “You are going to create a two-tier system and history shows that when you create division within society it leads to civil unrest. It’s vaccine apartheid.”<sup>[25]</sup>

What was said to be conspiracy theory a year ago – the idea that people could have their lives restricted for not vaccinating – that is, exercising their fundamental right to decline to be human guinea pigs, is no longer a conspiracy theory. It’s a conspiracy fact.

Today, regardless of claims of freedom and democracy, all governments are hell bent on injecting Covid-19 vaccines into their citizens by *any means necessary*. But I think that you – my fair-minded human friends, will agree informed consent necessarily means the right to refuse. The only other kind of consent is 1984 Big Brother style, *New Normal*.

Christine Massey, a New Zealand researcher and others have used Freedom of Information requests to various medical institutions and public health bodies in Canada, New Zealand, Australia, Germany, UK, USA, etc, seeking documentary evidence of COVID-19 virus from an unadulterated sample from a diseased human being.

By the end of 2020, some 40 responses had arrived from Canada, USA, New Zealand, Australia, UK, Ireland, Denmark, and the European CDC. *None of whom*, could locate any record describing the isolation of any “COVID-19 virus,” taken from a diseased patient.<sup>[26]</sup>

\*\*\*\*\*

You also need to consider another pertinent matter, my heavily fear-mongered and caught in the headlights rabbit friends. Not only will the vaccine be mandatory – in all but name, manufacturers have been given total immunity from any legal actions, no matter the injuries or deaths caused by their vaccine.<sup>[27]</sup> So where’s the incentive in making it as safe as possible?

States with longer, stricter lockdowns actually had larger Covid outbreaks. The five places with the harshest lockdowns: District of Columbia, New York, Michigan, New Jersey and Massachusetts, had the heaviest caseloads.
